Secure and Verifiable Documents to Be Accepted as Proof of United States Citizenship for DECAL Scholars Programs Under O.C.G.A. § 50-36-2

- An unexpired driver's license issued by one of the United States, the District of Columbia, the
 Commonwealth of Puerto Rico, Guam, the Commonwealth of the Northern Marianas Islands, the United
 States Virgin Island, American Samoa, or the Swain Islands, provided that it contains a photograph of the
 bearer or lists sufficient identifying information regarding the bearer, such as name, date of birth, gender,
 height, eye color, and address to enable the identification of the bearer [O.C.G.A. § 50-36-2(b)(3); 8 CFR §
 274a.2]1
- An unexpired United States passport or passport card [O.C.G.A. § 50-36-2(b)(3); 8 CFR § 274a.2]
- An original or certified copy of a birth certificate issued by a State, county, municipal authority, or territory of the United States bearing an official seal [O.C.G.A. § 50-36-2(b)(3); 6 CFR § 37.11]
- A Certificate of Citizenship issued by the United States Department of Citizenship and Immigration Services (USCIS) (Form N-560 or Form N-561) [O.C.G.A. § 50-36-2(b)(3); 6 CFR § 37.11]
- A Certificate of Naturalization issued by the United States Department of Citizenship and Immigration Services (USCIS) (Form N-550 or Form N-570) [O.C.G.A. § 50-36-2(b)(3); 6 CFR § 37.11]
